These are our work colleagues, friends, neighbours, relatives, and family members. Shocking as that statistic is the positive message is that these conditions can be improved or control managed by adopting an active healthy lifestyle. 2.45pm	Onshore gas exploration and extraction: implications for rural communities.	<p>The Department of Energy & Climate Change is currently offering up large areas of Scotland for auction, including a broad central swathe from East to West coasts, and a significant area of South West Scotland, for onshore oil and gas exploration. The hope is that gas can be extracted from deep underground, either from coalbed methane or shale deposits. However, this technology has proved highly controversial elsewhere.</p> <p>In addition to persuasive evidence that it creates significant environmental and public health threats, is likely to be damaging to other rural businesses, and lead to major industrialisation. 4pm	Revolutionising health care in the Highlands and Islands	How the Dewar Report of 1912 was the direct forerunner of the NHS and how we are using the lessons learnt to reinvigorate remote and rural health care in Scotland in the 21st Century" RCGP Scotland led a project to celebrate the Dewar Report of 2012. Since then we have realised the issues of the last century are still relevant to the present recruitment crisis in Scotland. We have published the "Being Rural" policy document that gives an action plan for change.
